EACH ISSUE COVERS A DIFFERENT AGRICULTURE OR NATURAL RESOURCE TOPIC AND IS PROVIDED FREE OF CHARGE. A TOTAL OF 60,000 COPIES OF EACH ISSUE WERE PRINTED AND DIRECTLY MAILED TO 1,675 CLASSROOMS IN BOTH URBAN AND RURAL COMMUNITIES ACROSS COLORADO, REPRESENTING 730 SCHOOLS, ORGANIZATIONS, AND CSU EXTENSION OFFICES.
