Twenty-five dollars (\$25) of the initial cost and annual renewal fee goes directly to New York Agriculture in the Classroom's programs that foster awareness, understanding, and appreciation of our food and fiber system.

You can order your Ag Tag anytime—you need not wait until your vehicle registration is due. *If your registration expires in 60 days or less, you must renew it before you can order these plates.*

Passenger and commercial vehicles are eligible—a great opportunity for individuals and businesses to show support for NY agriculture and agricultural education.

Standard Custom Plate Initial Cost: \$53.75

Standard plates consisting of three numbers ranging from 100-999 followed by the letters AGR will be assigned by DMV according to the next available number. There is a \$25 annual renewal fee in addition to your regular registration fee, which is billed every two years at the time of your renewal.

Personalized Custom Plate Initial Cost: \$85.00

There is a \$56.25 annual renewal fee in addition to your regular registration fee, which is billed every two years at the time of your renewal.
